## STRUCTURE FEATURES AND CONTROLS

- Industrial primer coated mild steel construction.
- Accommodates extra-large, claustrophobic persons, wheel-chairs, trolleys, bulk items, and fire etc emergency evacuation situations without the need of an adjacent emergency exit door.
- Secure door position monitoring, control and door alarm contacts
- LED electronic fault finding diagnostic for easy fault finding
- LED AC power and emergency battery status indicator
- Costly floor space savings achieved with the small footprint

- Fits into standard door openings with minor modifications as well as pass through standard doorways, passages, lifts etc to facilitate installations at various venues.

- Dismantled, refurbished and re-used as often as required, whilst handling continuous high volume traffic

- Discourages hold-up, hostage and tailgating situations.

- Electronic beam detection, enhanced with horizontal hip high and a lower set of infrared curtains consisting of 3 transmitters and 3 responding receivers each inside the cubicle, time delay overrides unlocking and override restriction features with an applicable warning notice fixed to the outside of the unit

- Remote control and monitoring of above facilities.

- Interface with all reputable building management systems incorporating technology such as Bio metric readers with audit trail facilities.

- Facilities for Pin Lens cameras behind full length opaque lenses.

- Ballistic levels up to AK 47 and R1 rifles.

- Special Powder coating or final finish to suit individual requirements.
